While at WCNA I attended a workshop for BMLT (Basic Meeting List Toolkit) which we are currently using to generate our meeting lists as well as our meeting lists on our website. The developers are all addicts and are working on this for free. They are in process of setting up the infrastructure to consolidate meeting data worldwide. We are already in the system.

They also have some new toys that I am working on implementing for the phone line that will pull from the central database so the phone line will stay current. It also has an option to configure for a live person and is easy to set up. I hope to have this ready for testing at the next ASC. It is possible that a future date we can consolidate one phone number for the whole region that'll give you meeting info for that day based on your location, requested city or zip code.

Check out an Android App by these same developers BMLT search. It is available in Google Play. An IOS App will be coming out any day now.

I have also been looking into the feasibility of setting up a printer at the Survivors Club to print out meeting lists, flyers, etc. I have brought some information for ASC to look over. (Motion created)
