Hello Family!

1. PSA's can be made available to run on local television. Jared L. , PR subcommittee chairman from the New Orleans Area has edited some videos for North Louisiana Area as an example. We are working to get them on our local stations. They are posted at www.nlana.net. Look them over and let me know if you'd like some edited for your area.
2. The BMLT database is in approaching golden. North Louisiana, Bayou, Northshore, and New Orleans areas are keeping their information up to date themselves. If possible I request that the ASR's from Central, Lake, Unity & Acadiana areas get with me some time this weekend to discuss setting up access so they can do the same. A bmlt portal has been set up at <https://blacksheepna.org/bmlt-portal/>. This is an app I found with the BMLT stuff on github. Steve will put in on larna.org when he gets time but this is where it is at now. The most useful function of the portal is you can generate proof reports, meeting lists with room to mark up and make changes. Print them out and give them to your GSRs and have them mark up any changes and turn back in to you. The other two links are to the BMLT Root Server and to change history. You can sign right in to the root server and make the changes the GSR's requested. As there are more and more services that depend on this data – including NAWS - the more accurately we keep this database the better we can “carry the message to the still suffering addict.”
3. The Regional website is being utilized much more efficiently. I think most of the typos, dead links, and mistakes have been fixed. Let me know if you find something we overlooked. I hope to get more docs posted to the website such as motion forms, ASR Report Forms, NA posters that can be edited to use by multiple service bodies, etc. Y'all send me anything that you think could be useful to other groups/areas. Thank you all who have sent me or Steve S. events to post on the event calendar. It's pretty cool to have one source that aggregates the activities from the whole region. I hope this encourages more contact between areas and be a key piece help foster a sense of togetherness throughout the region. Please keep sending me flyers and other info. I do ask that you send electronically generated documents because scanned copies are too poor quality for posting to the internet.
4. Bayou Area has been using yap for their helpline for a few months with good success and The Black Sheep Group of NA from Springhill has recently added a yap helpline. Northshore Area of NA is in process of switching to yap. I would encourage other areas to consider it. Let me know if I can help. I hope to have a proposal at next RSC in July on the merits of implementing a Region wide helpline number that would dispense meeting information and route callers wishing to speak to someone to the appropriate area volunteers. By then we should have enough data from Bayou, Northshore, and Black Sheep Group's usage of yap to make an informed decision.
5. June 3rd through 9th is the first annual NA PR Week. I have a flyer from NAWS with some ideas that are being passed around and would like to discuss this and get your thoughts on it.
6. A forum has been set up to get input for a PR workshop to be held in Alexandria. It is at www.prday.blacksheepna.org . The forum requires a username and password for access. This is not to exclude anyone but to prevent the forum from being spammed. Please anyone interested in contributing to the discussion contact me and access credentials will be furnished.
7. I'd like to thank Allison L., Sean S., Trevis J., Jared L., and many others as well as Pixie S. and the officers of the RSC for all their help and support – and especially my home group just for the fact they have to put up with me.

Information of Interest**B. O. D. Chairperson**

Members and Trusted Servants of the Louisiana Region:

As is our custom, we are including minutes for the HCC meetings (LRCNA 37 11/25/18, 12/30/18, 1/27/19, 2/24/19, and 3/17/19; and LRCNA 38 2/10/19) along with this report. We also had LRCC Board meetings on January 13, and March 10, 2019 and those minutes are also being submitted. LRCNA 37 is only 7 weeks away so I want to remind all of you to please, please, please, call the Clarion Hotel and make your reservations! (May 17-19, 2019). If you don't do that by the cutoff date (April 26th) then you'll lose out because the room rate may end up being much higher than the convention rate of 85.00 / 95.00. And the convention will lose out because if we don't rent the number of rooms we promised, we will end up having to pay more for the meeting space! So please make reservations with the hotel now. If something happens and you can't make it, as long as you cancel 24 hours out it won't cost you anything.

Plans for the convention seem to be coming together nicely. We've signed a contract for a band called Kat fight, we're about to sign a contract for a DJ and video person, and our new "flat fee," vendor contracts are in place, including a contract for Lone Star Region to sell literature at the convention this year.

You may or may not remember but we've talked at length over the past year about buying a laptop or tablet for the Host Committee to use. They would use it for entering and tracking registration data during the convention and the Treasurer would use it over the entire year to keep the books. Well, we've finally pulled the trigger on that and bought a "Panasonic Toughbook." We intend to set it up with the needed software and turn it over to LRCNA 37 for use at this year's convention.

We're in the process of getting the elected officers for LRCNA 38 authorized as signers on the bank account for that convention. We also had a credit card machine bite the dust and will have to replace that, but LRCNA 38 will still have a credit card machine for their pre-convention sales at the close of this years convention. Finally, a meeting is scheduled for next week with the hotel in Alexandria to try and negotiate a final contract. More will be revealed!

I reported previously that addicts from Lafayette had approached me asking about bidding procedures for LRCNA 39 and I did send them the bidding guidelines and offered whatever assistance they might want in considering a bid. I have not heard anything more from them. I have, however, been approached by someone in the Greater Baton Rouge Area and I am sending them the guidelines. Hopefully we will have a bid from one of these groups, or perhaps from someone else, to present soon. One of our expenses has been about \$700 per year for a climate-controlled storage area. We needed that to keep banners from previous conventions from deteriorating. Now that hotels will no longer allow us to hang these though, and we're shifting to keeping digital images of banners, there's really no reason for us to keep this storage area. We may keep a smaller, non-climate-controlled area for easels and coffee pots and such, but we plan on vacating the current storage area as early as next month. This means the file cabinet we have been keeping for Region needs to be moved. The RSC chair has looked at it and can talk about what is in it. Hopefully y'all will make a decision this weekend about what you want to do with it.

Finally, for the past couple of years, the LRCC's regular meetings have been held at St. Patrick's Church in Baton Rouge. Beginning in August, however, we will have our regular meetings at Grace Baptist Church, Richland Ave, Baton Rouge as that location and facility is simply better suited to our needs.
