- Activities Chair will be solely responsible for having the Square Application on their phone and for charging Camp Recovery individual items.
- All account information will not become public; but kept private.
- When new Activities Chair is voted in they will need to download App and have access to e-mail.
- All fees will be incorporated in pricing for Camp Recovery items; including shirts, coffee mugs, registration, auction, etc.
- Statements will be turned in with Activities report; Statements will be mailed to the P.O. Box.
